The Julius Meinl Scratch & Win Initiative ("**Scratch and Win Initiative**") is organized by Julius Meinl Coffee Intl., a.s., Vajnorská 100/B, 831 04 Bratislava ("**Julius Meinl**"). Participation is free of charge. By participating, the participant accepts the following Terms and Conditions.

1 ELIGIBILITY

- 1.1 Participants must be at least eighteen (18) years old.
- 1.2 Legal representatives and employees of Julius Meinl or any third-party companies involved in organizing the Scratch and Win Initiative are excluded from participation.

2 PROMOTION PERIOD

- 2.1 The promotional period runs from October 1, 2025, to October 5, 2025 ("**Promotion Period**").
- 2.2 Prizes must be redeemed no later than October 31, 2025. Late claims will not be accepted. Promotion dates may vary depending on location restrictions.

3 PROCEDURE

Kofi Bar – Petrzalka, BA) during the Promotion Period will receive a Scratch-and-Win-Card, subject to availability. A limited number of Scratch-and-Win-Cards defined at the discretion of Julius Meinl is attributed to each participating outlet.

- 3.2 The purchase price paid for one (1) or more Julius Meinl coffee(s) by the Participant shall be deemed to be 100% attributable to the purchased goods. The reception of the Scratch-and-Win-Card shall be deemed free of charge and no extra price is to be paid for the issuance of such Scratch-and-Win-Card.
- 3.3 To win, participants may scratch the Scratch-and-Win-Card to reveal two (2) matching icons. The revealed icons indicate the Prize won. Not every Scratch-and-Win-Card offers the right

combination of icons to claim a Prize. E.g. the Scratch-and-Win-Card shows two (2) icons picturing coffee cups, the participant wins one (1) free cup of Julius Meinl coffee.

3.4 Only one (1) Scratch-and-Win-Card will be issued per individual transaction.

3.5 Scratch-and-Win-Cards have no monetary value, cannot be sold or exchanged, and must be presented at the same participating outlet, where the Scratch-and-Win-Card was issued.

4 PRIZE

4.1 Each Scratch-and-Win-Card offers the chance to win one (1) cup of Julius Meinl coffee.

4.2 The participant may select their preferred type of coffee, subject to availability at the participating outlet.

4.3 Julius Meinl expressly reserves the right to replace the announced prize with equivalent or higher-value prizes without stating any reasons.

4.4 Not every Scratch-and-Win-Card includes a Prize. Lost, defaced, copied, or illegible Scratch-and-Win-Cards will not be accepted.

4.5 Prizes are non-cash convertible and non-transferable.

5 DISQUALIFICATION

Participants may be disqualified for violating the rules or submitting more than ten (10) Scratch-and-Win-Cards per day. Julius Meinl reserves the right to revoke and reclaim Prizes in such cases.

6 LIABILITY
